LEADERSHIP GIVING – TOCQUEVILLE SOCIETY

The United Way Tocqueville Society recognizes local philanthropic leaders and volunteer champions in the United States, France and Romania who have devoted time, talent, and funds to create long-lasting changes by tackling our communities’ most serious issues.



Renowned French political philosopher Alexis de Tocqueville admired three elements in North American society: liberty, equality and the spirit of neighbor helping neighbor. These same elements are embraced in the French national motto: “Liberté, Egalité, Fraternité.” Tocqueville believed that by achieving these elements of democracy, all people would choose to pursue freedom, knowledge and prosperity, or indépendance, connaissance, and prospérité.

Today over 25,000 Tocqueville members strong, since 1984 over \$9 billion has been contributed by Tocqueville members. Membership in the Society is granted to individuals who contribute at least \$10,000 annually to United Way. National Society Membership is granted to individuals who contribute \$100,000 or more per year to the United Way. Partnership with the United Way’s Million Dollar Roundtable is limited to individuals who have contributed \$1,000,000 or more to the United Way mission and impact work.

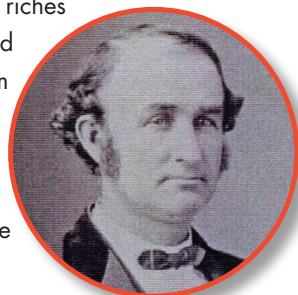

LEADERSHIP GIVING – PETER HERDIC SOCIETY

Born in Fort Plains, New York, in 1824, the promise of lumber riches brought Peter Herdic to Pennsylvania in 1853. In 1857, he and two other local businessmen purchased the Susquehanna Boom Company. Using his political influence, Herdic then convinced the legislature to raise boom tolls from \$.50 to \$1.25 per thousand feet of logs. In its peak year in 1873, the boom processed nearly 320 million feet of logs, earning considerable profits for Herdic and his partners.



In 1869, Herdic was elected as the third mayor of Williamsport. He owned the gas works and sold land to the railroads to bring them into the city (routing them through other Herdic property to increase its value). He built office buildings, a waterworks, an urban railway, and a bridge over the Susquehanna River. Herdic also owned the local newspaper. But in addition to his business enterprises, he donated homes to the working class, erected churches on donated land, and constructed public buildings and signed them over to the city. Some sources claim his philanthropic activities severely depleted his finances and that he hovered between wealth and ruin on a yearly basis.

DISTINGUISHED VOLUNTEERS

2017 Douglas C. Dickey Humanitarian Award

Former campaign chairs and board members, Dr. John and Margaret Piper have been selected to receive the Lycoming County United Way's highest honor, the Douglas C. Dickey Humanitarian Award.

The award is presented annually to individuals whose dedication, commitment and outstanding leadership have made a major contribution to the welfare of Lycoming County. Presented since 1947, the award was renamed in 1997 to honor the memory of former United Way Board President, the late Douglas C. Dickey, who lost his life in the crash of TWA Flight 800.

"As a past award recipient, I am honored to welcome John and Margaret as our latest Dickey award recipients," reflected Ron Frick, President of the Lycoming County United Way. "John and Margaret have worked tirelessly, not only for our United Way, but for the community as a whole. We are grateful for their life of servant leadership and for their work on behalf of our organization."

John and Margaret Piper moved to Williamsport in 1969. It was Margaret's first trip to town but John had lived here earlier in his life, long enough to graduate from Williamsport Area High School in 1954. They came to town when John accepted a position in the History Department at Lycoming College.



John continued at the College until he retired in 2007, serving in the History Department and then as Dean of the College from 1992-2007. He served as Pastor of Duboistown-Nisbet United Methodist Charge from 1975-1984 and then as Pastor of Grace United Methodist Church from 1984-2004. Margaret worked at Hope Enterprises, Head Start, and then became Special Needs Coordinator at Penn College and Lycoming College. She served as Instructional Support Teacher at Loyalsock Township School District until she retired in 2001.

The Pipers became involved in the community shortly after they moved to town. Margaret was founder of the local Learning Disabilities Association chapter. She served as Community Vice President of the Junior League, President of the YWCA Board, President of the Valley View Nursing Center Board, and was on the fourth judge commission appointed by Judge Thomas Raup. She was elected to the Loyalsock Township School Board in 1979 and served fourteen years, and later served another four years. She served as President of the Board twice. She has been active in the United Methodist Church, singing in church choirs and serving on several committees. John became involved in the West Branch Plan for Equal Opportunity at the invitation of P.D. Mitchell and later served on the Board of the Bethune Douglass Community Center. He has served as President of the Board of the West Branch Drug and Alcohol Abuse Commission, President of the Board of the Children's Development Center, and President of the Board of the Lycoming County Historical Society. He was one of the authors of a history of Williamsport and the author of a history of Lycoming College.

Both Pipers became involved in the United Way in the 1970's. Margaret served on the allocations committee and served as co-chair of the Loyalsock Township School District campaign committee for several years. John served on the campaign committee for over fifteen years. They accepted the challenge to be Campaign Co-Chairs for the 2016 Campaign.

John and Margaret believe that the United Way is the fulfillment of the original vision of community philanthropy which was called the Community Chest. The idea behind the Community Chest was that people working together and reaching out to those in their midst in need achieved the best kind of community. They have appreciated the opportunity of being part of that effort.
